## **INTERNATIONAL MEETING 2025** **4-8 JUNE 2025**

### **REGULATIONS**

#### **A – REGISTRATION**

1. The International Meeting is open to members of the *barchetta Club Italia* and non-members (hereinafter referred to as “**Member**”) who own a Fiat *barchetta*.

Registrations will be considered in the order in which they are received. The number of participants is **to a maximum of 85 barchetta**. All additional registrations will be placed on a waiting list, which will be updated on an ongoing basis due to possible cancellations.

2. Participation **in the entire International Meeting** costs €645 per person. Accommodation in a single room costs an additional €120.
3. The member wishing to attend the International Meeting must confirm his/her interest by filling in the registration form on the website [www.barchetta.it](http://www.barchetta.it) by **31 March 2025 at the latest**.

Within the same deadline, the Member is required to pay a pre-registration fee of €100 per participating *barchetta* to the following bank account: IBAN IT93 D030 6909 6061 0000 0129 542, Banca Intesa Sanpaolo, in the name of: *barchetta Club Italia*, 00172 Rome.

Payment by the deadline is required; failure to do so will result in exclusion from the participant list.

The €100 pre-registration fee will be deducted from the total amount. The remaining balance must be transferred to the *barchetta Club Italia* as per the instructions in paragraph 5.

4. Members who cancel their participation must submit a written waiver to the *barchetta Club Italia* ([info@barchetta.it](mailto:info@barchetta.it)) **no later than 30 April 2025**. The €100 pre-registration fee will be refunded to the cancelling member by bank transfer.
5. Those attending **the entire International Meeting** should transfer the following amounts by the specified deadlines (failure to do so will result in exclusion from the participant list):
  - €300 until 30 April 2025;
  - €245 until 20 May 2025;
  - the single room surcharge of €120 (if applicable) until 20 May 2025.

## **B - PARTICIPATION**
